As Chairman of MENZSHED NZ it gives me great pleasure to present this annual report. Over the last year I have been the chairman of this organization and have been privileged to have had a hard working team to support me, the Secretary, Treasurer, Support Services role and the Regional Representatives. The executive have responded to many enquiries from our web site, emails and phone calls regarding all manner of things. Regional reps have been very active answering enquiries as well as visiting MENZSHEDS in their regions. It is worth noting that all positions in our organization are held by volunteers. Members of the executive give freely of their time and only receive a small amount of funding towards the running cost of their vehicles and overnight stays if needed.

MENSHEDS are seen as part of a very worthwhile organization within communities and provide a wide range of services. These range from kidsfest activities to assisting with aged folk, providing predator traps to eradicate rodents, community seating and tables and much more. It is pleasing to see the range of activities the sheds are involved in. This is evident through the articles that are published in our quarterly newsletter. Thanks must go to John Bush for the quality presentation and content of this vital link with MENZSHED. Please sheddies make an effort to send articles in. We are all very interested in what is happening around our country.

We, the executive of MENZSHED NZ, do not interfere with the running of any shed. Our task is supporting sheds and providing resources to meet their needs. It is not our task to tell sheds how to run their shed. Different sheds have differing ideas and different communities have differing needs. The executive are always available to discuss an issue with a shed but we do not make a decision for the shed. As mature young men we trust you to work it out in a friendly manner with all members of your shed.

Over the past year there have been five sheds that met the requirements for membership, two sheds that needed further evidence that they met our criteria and gained membership, while one shed has to complete the process. Sheds that are working to join MENZSHED NZ are given a complimentary listing on our website. This enables them to be identified within their community while going through the setup stages. They are supported by our executive throughout this process.

This year we were again a nominee in the NZ Community Organization of the Year. This lifts our profile as we were one of the ten finalists. Being able to attend the function and spreading the word at a national award ceremony helps to reach out to businesses with the hope of further sponsorship opportunities.

Conference 2020: What are task. What a disappointment for the team lead by Ian Miller down in Dunedin. A special thanks also goes to James Sunderland for all the work he has done in setting up the conference. Who would have thought that the world could be turned upside down due to a virus and that the conference would need to be cancelled. The conference will be rescheduled to the same time next year and we hope that all businesses are still in a position to support us with their sponsorship.
